Sir,

With reference to your letter on the subject cited above, I am directed to say that for issuing of NOC an affidavit with the following conditions are required-

- I. The Institute/ College will not seek any financial assistance from State Govt., Grant in aid of any Kind.
- II. The Institute / College will obtain necessary approval / recognition from NCTE, maintain norms and standard fixed by NCTE and the affiliating University.
- III. The Institute/College will not seek or apply for Provincialisation in future
 - It should be clear from the Affidavit submitted by the colleges that the Govt. of Assam has no financial burden regarding the issue of NOC to Start B.Ed & D.El.Ed Courses at their Institutes / Colleges. Since these Institutes / Colleges would be run by self financing mode.
