RECOGNITION ORDER

WHEREAS, in terms of Section 15(1) of the NCTE Act, 1993, Kallabor College of Education, Street/Road-Kuwaritol, VIII-Kuwaritol, Taluka/Mandal-Kaliabor, Town/City-Kuwaritol, Dist-Nagaon, Assam-782137 (Application No. ERCAPP201648113) (ID-9572)) has applied for grant of recognition to D.El.Ed. Course online on 03.06.2016 for two year duration and hard copy received by Eastern Regional Committee of NCTE on 13.06.2016.

2. AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and report received from VT and videography, and the certificates received from the affiliating body, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

3. NOW THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993 and in accordance with Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014, the Eastern Regional Committee, NCTE hereby grants recognition/permission to Kallabor College of Education, Street/Road-Kuwaritol, VIII-Kuwaritol, Taluka/Mandal-Kaliabor, Town/City-Kuwaritol, Dist-Nagaon, Assam-782137 for conducting D.El.Ed. Course of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2022-2023.


4. The affiliating body to ensure that minimum working days as specified in clause 2.2 of Appendix-2 of NCTE Regulations 2014 are fulfilled alongwith staff profile as per NCTE norms.

5. The Endowment fund of Rs.5 lakhs and Reserve fund of Rs.7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.

6. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

7. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

8. The Institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course is always in position.

9. The recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, State Government etc, as applicable.

10. The Norms of staff qualification administrative and professional staff/terms and conditions of service etc shall be as per the provisions of NCTE Regulations, 2014.

11. The Institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.

12. The Institution shall maintain & update its website as per provisions of NCTE Regulations and always display the following as mandatory disclosure:-

- Sanctioned programmes along with annual intake in the institution;
- Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
- Name of faculty members who left or joined during the last quarter;
- Names of Students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- Fee charged from students;
- Available infrastructural facilities;
- Facilities added during the last quarter;
- Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
- The affidavit with enclosure submitted along with application;
- The institution shall be free to post additional relevant information, if it so desires.
- Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.

13. In case if the land is in the name of the Society/trust, the land is to be transferred within six months in the name of the institution, failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the within the stipulated time.

14. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by Ministry of Education.

15. If the institution contravenes the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17 of the NCTE Act, 1993.
